### HLTAID004 PROVIDE AN EMERGENCY FIRST AID RESPONSE IN AN EDUCATION AND CARE SETTING

The unit applies to educators and support staff working within an education and care setting who are required to respond to a first aid emergency, including asthmatic and anaphylactic emergencies. This unit of competency describes the skills and knowledge required to provide a first aid response to infants, children and adults. Unit of competency will contribute towards approved first aid, asthma and anaphylaxis training under the Education and Care Services National Law, and the Education and Care Services National Regulation (2011).

#### TARGET AUDIENCE:

Those who are required to provide an emergency first aid response in a workplace.

#### PREREQUISITE:

There are no prerequisites for this course.

#### AWARD ISSUED:

- HLTAID004 Provide an emergency first aid response in an education and care setting
- HLTAID003 Provide first aid
- HLTAID002 Provide basic emergency life support
- HLTAID001 Provide cardiopulmonary resuscitation

It is recommended this unit be renewed every 36 months in line with industry standards.

#### ASSESSMENT REQUIREMENTS:

**It is a Training Package requirement of this course that you are physically capable of performing uninterrupted CPR for at least 2 minutes on a CPR manikin placed on the floor.**

#### COURSE DURATION:

##### INITIAL COURSE:

- Face to Face: 8 hours (training, assessment & Practical Tasks)
- Blended Delivery: 6 hours + 2 hours pre-course study

##### REFRESHER COURSE:

- Face to Face: 6 hours (training, assessment & Practical Tasks)
- Blended Delivery: 6 hours + 2 hours pre-course study

### EXCEPTIONS FOR DURATION OF THE COURSE

Course durations are reflective of group sizes of between 4 and 15 students. If there are less students in a group, you may find course duration reduced by a maximum of 10%. If a class size exceeds 15 students, it may therefore also be necessary to increase course duration depending on the number of students.

### RE CERTIFICATION REQUIREMENTS:

It is recommended HLTAID001 Provide cardiopulmonary resuscitation unit be renewed every 12 months in line with industry standards.

### PRE COURSE STUDY OPTIONS:

If there is pre-course study for the course, it is found in the student portal. Students must have access to a computer, phone, tablet etc. with access to the internet to complete the pre-course study online. The pre course study includes a short self-assessment knowledge quiz. You must take the completed paper with you to the training course.
