SET - UETDRRF06B (LV PANEL) & HLTAID001 (CPR)

This unit describes the skills and knowledge required to use specialised equipment in the provision of resuscitation in line with the Australian Resuscitation Council (ARC) guidelines.

TARGET AUDIENCE:

This Competency Standard Unit covers the performance of rescue procedures from live Low Voltage (LV) apparatus, not including overhead lines and underground cables in the workplace. It specifies the mandatory requirements of rescue from a live LV panel and how they apply in the context of transmission, distribution or rail work functions.

It encompasses responsibilities for health, safety and risk management processes at all operative levels and adherence to safety practices as part of the normal way of doing work. Industry standards for refresher training vary from state to state. Most states recommend refresher training for this unit every 12 months.

PREREQUISITE:

HLTAID001 Provide Cardiopulmonary Resuscitation or qualifications deemed equivalent.

****Current copy of certificate must be provided at time of enrolment.**

AWARD ISSUED:

- HLTAID001 Provide cardiopulmonary resuscitation
- UETDRRF06B Perform rescue from a live LV panel

It is recommended this unit be renewed every 12 months in line with industry standards.

ASSESSMENT REQUIREMENTS:

It is a Training Package requirement of this course that you are physically capable of performing uninterrupted CPR for at least 2 minutes on a CPR manikin placed on the floor.

 - Face to Face: 5 hours (training, assessment & Practical Tasks)
 - Blended Delivery: 3.5 hours + 1.5 hours pre course study

EXCEPTIONS FOR DURATION OF THE COURSE

Course durations are reflective of group sizes of between 4 and 15 students. If there are less students in a group, you may find course duration reduced by a maximum of 10%. If a class size exceeds 15 students, it may therefore also be necessary to increase course duration depending on the number of students.

RE CERTIFICATION REQUIREMENTS:

It is recommended HLTAID001 Provide cardiopulmonary resuscitation unit be renewed every 12 months in line with industry standards.

You must take the completed paper with you to the training course.
